The appointee shall be on probation for a period of two years.



- iii. **Permanent Resident Certificate.**
- iv. **Character & antecedents certificate.**
- v. **Certificate from the concerned authorities to the effect that no loan under self employment Scheme (s) has been obtained/ availed by the concerned appointee.**
- vi. **Category Certificate, if any.**
- vii. **Any other relevant certificate as required under rules.**

If, on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled *ab initio*.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Addl. Director General, CID.

The concerned Drawing & Disbursing Officer will also verify the genuineness of the qualification certificates and other allied documents of the appointee.
