Whereas, the below mentioned candidates were selected by the J&K Services Selection Board vide communication No.SSB/Secy/Sel/2018/4101-07 dated:-12-04-2018 against the posts of Assistant Handicrafts Training Officers Divisional Cadre, Kashmir:-

Whereas, the Administrative Department vide their communication No.IND/DOH/31/2017 dated:-04-06-2018 conveyed approval for their appointment against the aforementioned posts; and

Whereas, the formal appointment order in favour of aforementioned candidates among others were issued vide this office order No.494-HD of 2018 dated:-13-06-2018; and

Whereas, thereafter the aforementioned 04 candidates/appointees failed to join their places of appointment within 21 days (even till date); and

Whereas, the aforementioned selected candidates/appointees were asked to join the Department within a period of 07 days through a notice which was published in prominent dailies of the state vide this office No.HD/Estt/A/3159-62 Dated:-24-10-2018. But the candidates failed to join the department within the stipulated time period; and




Whereas, vide this office No.HD/Estt/A/4710-13 dated:-19-11-2018 2<sup>nd</sup> notice to the aforementioned selected candidates had been issued duly published in prominent dailies of the state wherein they were asked to join the Department within a period of 07 days, but the candidates failed to join the department within the stipulated time period; and

Whereas, vide this office No.HD/Estt/A/5334-37 dated:-15-01-2019 final notice to the aforementioned selected candidates has been issued, duly published in prominent dailies of the state wherein they have been asked to join the Department within a period of 07 days. But despite issuance of several notices, the candidates have not joined the Department till date as reported by the Joint Director Handicrafts, Kashmir vide communication No.HD/JDHK/Estt/Gen-297/2051 dated:-15-01-2019;

Now, therefore, in light of above, the appointment order bearing No.494-HD of 2018 dated:-13-06-2018 issued under endorsement No.HD/Estt/A/1740-57 dated:-17-06-2018 in respect of the aforementioned four selected/appointed candidates against the posts of Assistant Handicrafts Training Officers, Divisional Cadre Kashmir is hereby cancelled ab-initio.
