Whereas, the below mentioned candidates among others were selected by the J&K Services Selection Board vide communication No.SSB/Secy/Sel/ 2018/ 4101-07 dated:-12-04-2018 against the posts of Assistant Handicrafts Training

Whereas, the Administrative Department vide their communication No. IND/DOH/31/2017 dated:-04-06-2018 conveyed approval for their appointment against the posts of Assistant Handicrafts Training Officer; and

Whereas, the formal appointment order in favour of aforementioned candidates among others were issued vide this office Order No.493-HD of 2018 dated:-13-06-2018; and

Whereas, thereafter the aforementioned 02 candidates/appointees failed to join their places of appointment within 21 days (even till date); and

Whereas, the aforementioned selected candidates/appointees were asked to join the Department within a period of 07 days through a notice which was published in prominent dailies of the state vide this office No.HD/Estt/A/4261-63 dated:-12-10-2018. But the candidates failed to join the department with the stipulated time period; and

Whereas, vide this office No.HD/Estt/A/5024-26 dated:-06-12-2018, 2<sup>nd</sup> notice to the aforementioned selected/appointed candidates had been issued, duly published in prominent dailies of the state wherein they were asked to join the Department within a period of 07 days, but these candidates were failed to join the department within the stipulated time period; and

Whereas, vide this office No.HD/Estt/A/5702-04 dated:-15-01-2019 final notice to the aforementioned selected candidates has been issued, duly published in prominent dailies of the state wherein they have been asked to join the Department within a period of 07 days. But despite issuance of several notices, the candidates have not joined the Department till date as reported by the Joint Director Handicrafts, Jammu vide communication No.JDHJ/Estt/2703 dated:-04-02-2019; and

Now, therefore, in light of above, the appointment Order bearing No.493-HD of 2018 dated:-13-06-2018 issued under endorsement No.HD/Estt/A/1728-39 dated:-13-06-2018 in respect of the aforementioned two selected/ appointed candidates against the posts of Assistant Handicrafts Training Officer, Divisional Cadre Jammu is hereby cancelled ab-initio.
