- vi. Category Certificate, if any.
- vii. Any other relevant certificate as required under rules.

Pending verification of the relevant certificates *viz.* Qualification/ Character & Antecedents etc, from the concerned quarters, the appointee shall be allowed to join on the production of affidavit as per Annexure I to this order. The appointee shall report in the office of Joint Director (Handicrafts), Jammu, within 21 days from the date of issue of this order, failing which the appointee shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

However, the salary of the appointee shall be drawn and disbursed in her favour, only after her character and antecedents report is received from the Additional Director General, CID.

If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

The appointee shall be governed by the 'New Pension Scheme' as notified *vide* SRO-400 of 2009, dated 24.12.2009.

The concerned Drawing & Disbursing Officer will also verify the genuineness of the qualification certificates and other allied documents of the appointee.
